The accompanying summarized financial statements, which comprise the summarized statement of financial position as at **March 31**, **2022** and the summarized statement of revenues and expenses and changes in fund balances for the year then ended are derived from the audited financial statements of Saskatoon City Hospital Foundation Inc. for the year ended March 31, 2022. We expressed an audit opinion on those financial statements, modified for the completeness of donations, in common with many not-for-profit organizations, in our report dated June 16, 2022.

The summarized financial statements do not contain all the disclosures required by Canadian accounting standards for not-for-profit organizations. Reading the summarized financial statements, therefore, is not a substitute for reading the audited financial statements of Saskatoon City Hospital Foundation Inc.

1. Applied criteria



Message from the CEO

The 2021-2022 fiscal year was our second full year of operating during the pandemic.

While expectations could have been low, the Foundation knew that, based on results in 2020-2021, it could count on the support of people like you.

The year was the second full one of raising funds for the Equip for Excellence campaign. This multimillion dollar, multiyear campaign will benefit almost every department in the hospital.

Because of your ongoing support, new equipment was purchased for the Operating Room, Endoscopy, Surgery Services, the Eye Care, Women's Health and Breast Health Centres, Rehab, Medical Imaging, and the Emergency Department, to name more than a few.

In many cases, new equipment replaced items that were aging and beyond or nearly beyond repair; other equipment needed replacement because of the sheer volume of usage.


In 2020-21, the hospital saw just more than 150,000 patient visits and procedures. While this was a decrease from prepandemic levels of 200,000 visits and procedures during 2021-2022 saw that number climb back to almost 175,000.

As the province and Saskatchewan Health Authority work to return to normalcy in the wake of the pandemic – and deal with the backlog of procedures that was created – it's certain that usage soon will increase and surpass 200,000 visits and procedures again.

This is why it's important to continue funding Equip for Excellence and its lofty goal of raising more than \$15 million. Based on your past support of the Foundation and hospital, I fully expect that this goal will be achieved on target.

You can ensure that Saskaton City Hospital patients have access to the latest, best and safest equipment. For doing that, I sincerely thank you!



SASKATOON CITY HOSPITAL USAGE 2021-2022








Here are some examples:

The Women's Health Centre needed to quickly replace an exam table. It had a broken heel holder that could harm a patient should it let go while in use. The table was determined to be unrepairable. By funding this table, you've ensured safety for up to 40 patients a week.

Last year former Foundation employees
Randy Kershaw and Noreen Matthews
agreed to support the Early Pregnancy
Assessment Clinic (EPAC) in the
Women's Health Centre (WHC) with funds
from the Kershaw Palliative Endowment.


The FPAC is dedicated to meeting the psychosocial, investigative and medical needs of women and families experiencing complications and loss early in pregnancy. It promotes family centered care in a comfortable and supportive environment with follow up from a registered nurse and nurse practitioner, consultation from obstetricians or gynecologists for surgical management, social work and other grief and pregnancy loss resources.

Because of you, staff in the Rehab ward are working with a new Tran-Sit® Car Transfer Simulator. The equipment teaches hospital patients how to exit and enter vehicles safely and without the need for parking lot sessions, which can be dangerous. "Getting in and out of vehicles is generally something that we don't

think about," explains Marla Fieber, unit manager. "For Rehab ward patients, due to the changes in their physical mobility post stroke, brain injury or spinal cord injury, it can be challenging. The Tran-Sit ® Car Transfer Simulator is safe, convenient and can be used right on the ward."

Surgical residents in the hospital's Eye Care Centre are learning from and practicing on a new EyeSi surgical simulator, generously supported by funds from the Doctor C. H. and Lenore Andrews Scholarship and Research Endowment.

"The simulator teaches cataract surgery," says resident Dr. Melody Wong. "We learn every single step, and practice them independently in a safe manner before we participate in surgeries."



Support from donors like you saw the addition of a surgical simulator to the Eye Care Centre.

Donor gifts also supported the purchase of a Sonesta S3 table for Ambulatory Care's gynecology, cytology and urology procedure room. The new table is easier to move or adjust and can support bariatric patients.

"Our previous chair had seen several years of use and was starting to show its age," says Anne-Marie DeWeert, former comanager of the hospital's Endoscopy department.

"One of the greatest advantages of the new chair is that it provides a much lower starting point so patients are not struggling to hoist themselves into the chair."

Staff in the Operating Room were thrilled with upgrades to its cystoscopy suite. "I don't think there's anybody happier with the improvements than me," says Sanja Jovic-Filipovic, equipment resource nurse who previously worked as an O.R. nurse.

"The old bed wasn't ergonomic and our backs were always sore after a procedure – patients were uncomfortable, too. The whole room itself was cramped because the equipment was so large. It was like an obstacle course in the room and everyone was bumping into things.

"Having well-functioning equipment just makes everyone feel better and work happier," she adds. "That translates to patients, which is what it's all about. They're already stressed and anxious so anything we can do to make it better for them is great."

Well-known philanthropist Merlis Belsher stepped

forward to fund a new ultrasound for the Breast Health Centre, replacing a unit that was 16 years old and aging.

Radiologist Dr. Carolyn Flegg describes the ultrasound, used for 1,500 procedures annually, as "the workhouse of the centre. If we're going to do a needle biopsy of the breast under ultrasound, drain an abscess or cyst, or insert a wire localization for a mass on the day of surgery, this is what we use."

Longtime supporter of the Foundation, Merlis had a personal side to his donation. "I'd been diagnosed with a malignant gum ulcer and underwent several ultrasounds. It became obvious to me that the preciseness of imaging is extremely important to make the right decisions. Doctors do their best but it's our responsibility to provide them with the very best equipment."

Young man grateful for donor help

Last spring, the Foundation asked for your help to fund Dr. Matthew Mastel's new orthopedic surgery practice. The physician was just the first in Saskatoon and second in Saskatchewan to offer arthroscopy procedures.

"Arthroscopy is a procedure that uses a microscopic camera and tools to correct impingements in the hip," he explained in the March issue of Well Aware.

Used for preservation type procedures to delay the need for total joint replacement, he says it's one of the fastest growing areas of orthopedics in North America.

Because of your support, the Foundation purchased the tools he needed for the

procedure. This included a camera with a 70-degree scope, portals, suture passers, and anchors - all specialized because the hip is a deeper joint.

Your kindness paid off with the young man who was Dr. Mastel's first patient. Easton Genest is a 17-year-old dirt bike racer who had a mishap on his bike in 2021.

"While I was practicing, I crashed, and it threw me over and my bike landed on top of me. I broke my hip," he says.

While it healed, he continued to experience hip pain. He visited several doctors but surgery waiting lists were too long. He and his family even went to a U.S. surgeon who said he was fine

despite the pain. Eventually, a surgeon in Regina suggested he contact Dr. Mastel.

"Dr. Mastel said the injury was extensive enough that hip replacement was possible but because of my age and the fact I'm still growing it wouldn't have made sense."

Easton underwent arthroscopy and recovery. "I was on crutches for six weeks and did physio but I've returned to doing everything that I was doing before the fall. I'd even say that I was feeling better than I'd felt in the whole year after the crash."

He got back on the bike in late spring and was thrilled, "It felt brand new, I was feeling so comfortable to be back."



Not knowing anything about arthroscopy before meeting Dr. Mastel, he was surprised at how minimally invasive it was. "I thought I was going to have a cut down the whole side of my leg. I was amazed that it took only three little incisions and seven stitches. I was in the hospital for only a day."

Easton has a message for donors who made his surgery and recovery possible: "Thank you for getting the tools into Saskatchewan. I'm so glad to have this done so close to home. It's made my life better and I just have to say thanks a million."
